



## 2024 New Member Application for joining the Handgun Section at the Sportsmens Club, Galt

In order to be considered for membership in the Handgun Section you must be a member of the Sportsmens Club, Galt, possess a valid Restricted Firearms License, and be sponsored by at least one existing member of the Galt Handgun Section. **Also**, due to the Liberal Government freeze on Handgun transfers, you must currently own a handgun to become a member of the Galt Handgun Section.

**Applications will be accepted by email only beginning December 1, 2023 12:01AM. Any applications received before this time will not be considered. A limit of 80 applications will be accepted for the 2024 year.** No in person applications will be accepted.

You will receive a reply acknowledging receipt of your application along with instructions on how to arrange for the payment of the associated section and safety course fees. Once the application and fee details have been taken care of, here is what to expect:

**As a new member you must successfully complete the section's Club Safety Course followed by probationary shooting requirements before you are able to use the handgun range as a full member.**

The Club Safety Course is held on the 3<sup>rd</sup> **Saturday** of each month. Please note that only 6-8 new members are scheduled per month – you will be contacted by a section representative advising you of the date of your safety course. Once you have passed the Handgun Section Safety Course you are able to begin your probationary shooting requirements.

Probationary shooting requirements consist of 9 supervised shooting sessions plus a proficiency target. The supervised shooting sessions take place on Monday, Tuesday, and Wednesday evenings. Applicants unable to complete their probationary requirements within 3 months may be required to re-take the Club Safety Course.

Once your probationary requirements are completed you must then attend a monthly Handgun Section Meeting during which time your documents and probation results will be presented to the members in attendance for approval and acceptance into the Handgun Section.

Probationary members must attend their scheduled Safety Course, Probationary Shooting nights and the Section Meeting in order to become a full member of the Handgun Section. Dates and times will not be rescheduled for personal reasons.
