in any event not later than six months from the granting of
letters patent incorporating The Sportsmens Club (Galt) the
unincorporated association of the same name discontinue to
operate, and

That the President and Secretary of the association be
and they are hereby authorized to give, on behalf of the
association, an undertaking to discontinue operations and to
consent to the incorporation of Harry Allen and others under
the name of The Sportsmens Club (Galt).

AND IT IS HEREBY FURTHER ORDAINED AND DECLARED that if it is made to appear to the satisfaction of the Provincial Secretary that the premises occupied by the Corporation are equipped, guarded or otherwise constructed or operated so as to hinder or prevent lawful access to and inspection of such premises by police or fire officers or are found fitted or provided with any means or contrivance for playing any game of chance or any mixed game of chance and skill, gaming or betting or with any device for concealing, removing or destroying such means or contrivance, these Letters Patent may be cancelled by and in the discretion of the Lieutenant-Governor.

Harry Charles Allen, Manager; Daniel Evert Siegler, Licence Issuer; George Wesley Himes and Stanton Burnell Griffiths, Merchants; and Milton Robert Stuggins, Watchmaker; all of the City of Galt, in the County of Waterloo and Province of Ontario; constituting them and any others who become members of the Corporation hereby created a corporation without share capital under the name of

THE SPORTSMENS CLUB (GALT)

for the following objects, that is to say:

- (a) TO promote interest in and advocate legislation towards conservation of fish and wild life, and to prevent pollution of rivers, lakes and streams;
- (b) TO promote interest in skeet and trap shooting, rifle shooting, archery and all other varieties of outdoor sports and pastimes; and to operate ranges and places where skeet and trap shooting, archery and rifle shooting may be carried on and to hold competitions;
- (c) TO encourage a love of the out-of-doors and a spirit of good sportsmanship in our youth and to instruct boys, girls, young men and women in the proper use of firearms, bows and arrows and fishing paraphernalia;
- (d) TO encourage and foster tree planting, river and stream improvement and propagation of fish and wild life, and to undertake projects having these as their objects; and
